If you assert that you are exempt from the statutory penalty because, at the time of the violation described in the Notice, your vehicle was in the possession, custody, or control of another person, then you must provide the name, address, date of birth, and, if known, the driver's license number of the person who leased, rented, or otherwise had care, custody, or control of the vehicle at the time of the violation.
- 2. If you assert that you are exempt from the statutory penalty because, at the time of the violation described in the Notice, the vehicle was stolen, then the affidavit must include a copy of a police report showing the vehicle to have been stolen.
- 3. If you assert that you are exempt from the statutory penalty because a Uniform Traffic Citation was issued by a law enforcement officer under the same statute stated in the notice, then you must include the serial number of the Uniform Traffic Citation.
